

Introduction to the Affiliate Program

Our Affiliate Program is a big part of our values of community and access to opportunity.

We encourage all Coinmetro Affiliates to spread the word and encourage others to sign up and start benefiting from our range of products and services.

The Coinmetro Affiliate Program is subject to the below terms and conditions.

1. The Coinmetro Affiliate Program is subject to the Coinmetro Services Terms of Use. In the event of a conflict between the terms of the Affiliate Program and the Coinmetro Services Terms of Use, the terms of the Affiliate Program shall prevail.
2. In order to participate in the Coinmetro Affiliate Program, you need to have a fully verified Coinmetro Account. This will gain you access to set a custom URL to share with referrals.
3. The Coinmetro Affiliate Program is accessible for natural and legal persons accounts.
4. The Coinmetro Affiliate Program is limited to individuals and duplicate Coinmetro Accounts are not allowed. Coinmetro will check for duplicate, fake and fraudulent Coinmetro Accounts and any such accounts will be disqualified and deactivated with any referral bonuses being forfeited.
5. Only referrals who sign up using the Affiliate's referral link, QR code or referral ID will be registered as referrals who generate bonuses for the Affiliate.
6. There is no limit on the number of referrals for each Coinmetro account, although Coinmetro reserves the right to introduce such limits in the future.

7. Coinmetro strives to credit the bonuses you earn through your referral's activity to your Coinmetro account in real-time after the eligible trades have been completed. However, under certain circumstances, it may take longer for the bonuses to be credited.

8. Affiliates can cashout earned commission to their main wallet balance and use this on the Coinmetro platform or withdraw it to an external wallet.

9. Earned commission will be paid out in XCM, the native utility token of Coinmetro.

10. Unsolicited "spamming" of referral links in public spaces, online forums or messaging platforms and the use of any kinds of advertising methods deemed to be dishonest or misleading is forbidden. Affiliates are also forbidden to create or use marketing materials that contain dishonest, false or misleading information about Coinmetro and the Coinmetro Services or which tarnish the image or reputation of Coinmetro. This activity may lead to being disqualified from the program or having the account deactivated with any referral bonuses forfeited.

11. The use of Coinmetro's company logo and other Intellectual Property rights outside the Coinmetro Platform, including on any promotional materials, is only permissible with Coinmetro's prior written consent.

12. Nothing contained in the Affiliate Program shall be construed as creating an agency, partnership, employment of any type or other form of joint enterprise between you and Coinmetro and you certify that you will not make any representations to the contrary whether expressly, implicitly, by appearance or otherwise.

13. In the event that any provisions of the Affiliate Program Terms and Conditions shall be unenforceable or invalid under any applicable law or be so held by applicable court decision, such unenforceability or invalidity shall not render this Affiliate Program Terms and Conditions unenforceable or invalid as a whole. Coinmetro will amend or replace such provision with one that is valid and enforceable and which achieves, to the extent possible, our original objectives and intent as reflected in the original provision.

14. Coinmetro retains the right to deactivate Coinmetro accounts suspected of breaching the terms of the Affiliate Program, the Coinmetro Services Terms of Use, any other terms or agreements that may be specified by Coinmetro from time to time or any applicable law.

15. Coinmetro retains the right to change the terms of the Affiliate Program at any time at its absolute discretion.
